Infra Foch becomes Infra Park / VINCI Park adopts the Indigo brand and becomes Indigo Infra

On November 5th, 2015, **Infra Foch S.A.S. changes its corporate name to Infra Park S.A.S.**, to enhance the reference to its unique positioning as a worldwide leader in the car parking industry.

The strategy of the Group which it forms with VINCI Park remains unchanged, in line with the presentation made during the credit update held early October 2015. One of the major steps of this strategy, rolled out since mid-2014, was to build the Group a new identity.

Infra Park S.A.S. (previously named Infra Foch S.A.S.) holds about 100% of Indigo Infra S.A. (previously named VINCI Park S.A.).

Infra Park S.A.S. is indirectly held at almost 37% by an investment fund managed by ARDIAN, almost 37% by Crédit Agricole Assurances through its subsidiary Predica, almost 25% by VINCI Concessions (VINCI group), and the remainder by the Group's management.

About Indigo Infra

Indigo Infra S.A.S. (previously named VINCI Park S.A.) is a key global player in car parking and urban mobility, which manages 1.9 million parking spaces in 14 different countries. In 2014, its revenues and its EBITDA amounted to 733 million euros and 215 million euros respectively (Global Proportionate figures, pre IFRS 11).
