**Sébastien Fraise becomes President of the Executive Board
of the INDIGO Group**

Sébastien Fraise was appointed President of the Executive Board of the INDIGO group by the group's Supervisory Board on 24 March, 2023. His new mandate is effective since April 1st. He succeeds Serge Clémente, who will remain a member of the group's Executive Board until 30 June 2023.

This appointment is part of the reorganization of the INDIGO group proposed by Serge Clémente to its shareholders in autumn 2022.

"It is a change in line with the transformation plan we have launched to consolidate our historical parking activities, both on-street and off-street, but also to develop new services for the city, adapted to the environmental and societal transformations we are experiencing. The President of the Supervisory Board, Michel Bleitrach, on behalf of the group's shareholders, paid a tribute to the work of Serge Clémente, who joined the group in 2011 and has steered its development, both in France and internationally. He has also led numerous transformation projects, in particular the diversification of INDIGO's portfolio, digitalization and new business lines and services for the city. Under his leadership, the INDIGO group has become a world leader in parking and individual mobility, present in six countries in Europe (France, Belgium, Spain, Luxembourg, Switzerland, Poland), Brazil, Colombia and Canada.

Sébastien Fraisse, 51, is a graduate of the École Polytechnique and the École Nationale des Ponts et Chaussées. After starting his career at the Ministry of Public Works and then in the motorway sector (ASF and then VINCI Autoroutes), he joined the group in October 2012 as Deputy Managing Director in charge of France. He has been Managing Director of the INDIGO group since November 2022.

"I would like to thank the shareholders and Serge Clémente for the trust they have placed in me. Today, INDIGO is continuing to write its history, with a renewed management committee, which is carrying out the main lines of our strategic plan," says Sébastien Fraisse.

"In all our territories throughout the world, from our car parks to on-street parking, including our soft mobility offers and our services to the city (particularly last mile logistics), our business is at the heart of cities and local authorities. The group must continue to consolidate our positions in Europe and the Americas, which have made us a world leader, by offering global expertise in individual mobility and by positioning parking and our infrastructures as key assets for urban transformation"

INDIGO group is a French group and a global player in parking and urban mobility. It operates in 9 countries, on two continents (Europe, Americas) and employs nearly 10,000 people worldwide.

It operates 1,450,000 parking spaces in 2,568 car parks and 2,250 kilometers of on-street parking. Its activities cover, in a complementary manner, all types of parking (car parks, shared car parks) and the regulation of on-street flows (parking control and enforcement, expertise in low emission zones).

The INDIGO group has also developed services related to individual mobility (Cyclopark & Smovengo) and electric vehicles (fast charging stations in particular).

It is committed to the deployment of a single digital application for all its services with Indigo Neo.

The group is now exploring new services for the city and its residents, with the use of its indoor spaces for urban logistics, particularly last-mile storage.

The INDIGO group assists local authorities, as well as public and private players (hospitals, shopping centers, stations, airports, leisure and event areas, universities, etc.), in their urban mobility strategies.

In a booming mobility market, estimated at 140 billion euros in 2025 (according to a Businesscoot study published in 2022), the INDIGO group is a key player in the mobility of the future.
